



Florida Arbovirus Surveillance Week 18: May 3-9, 2015

Arbovirus surveillance in Florida includes endemic mosquito-borne viruses such as West Nile virus (WNV), Eastern equine encephalitis virus (EEEV), and St. Louis encephalitis virus (SLEV), as well as exotic viruses such as dengue virus (DENV), chikungunya virus (CHIKV) and California encephalitis group viruses (CEV). Malaria, a non-viral mosquito-borne disease is also included. During the period of May 3-9, 2015 the following arboviral activity was recorded in Florida.

WNV activity: No human cases of WNV were reported this week. No horses with WNV infection were reported this week. No sentinel chickens tested positive for antibodies to WNV this week. In 2015, positive samples from three sentinel chickens have been received from three counties.

SLEV activity: No human cases of SLEV were reported this week. No sentinel chickens tested positive for antibodies to SLEV this week. In 2015, a positive sample from one sentinel chicken has been received from one county.

EEEV activity: No human cases of EEEV were reported this week. Two horses with EEEV infection were reported this week in Bradford and Osceola Counties. Two sentinel chickens tested positive for antibodies to EEEV this week in Flagler and Orange Counties. In 2015, positive samples from 14 sentinel chickens and four horses have been received from seven counties.

International Travel-Associated Dengue Fever Cases: One case of dengue fever was reported this week in a person that had international travel. In 2015, 10 travel-associated cases have been reported.

Dengue Fever Cases Acquired in Florida: No cases of locally acquired dengue fever were reported this week. In 2015, no cases of locally acquired dengue fever have been reported.

International Travel-Associated Chikungunya Fever Cases: Two cases of chikungunya fever were reported this week in persons that had international travel. In 2015, 23 travel-associated cases have been reported.

Chikungunya Fever Cases Acquired in Florida: No cases of locally acquired chikungunya fever were reported this week. In 2015, no cases of locally acquired chikungunya fever have been reported.

Advisories/Alerts: No counties are currently under mosquito-borne illness advisory or alert. A CDC Health Alert Network (HAN) health advisory was issued in December 2013 for the Caribbean region announcing the first locally acquired cases of chikungunya fever in the Americas. There is a Level 1 (Watch) Travel Health Notice from the CDC for multiple countries in the Caribbean, Mexico, Central and South America, as well as the Pacific Islands related to the transmission of chikungunya. 2015 Human Case Summary*

International Travel-Associated Chikungunya Fever Cases: Twenty-three cases of chikungunya with onset in 2015 have been reported in individuals with travel history to a chikungunya endemic country or area experiencing an outbreak in the two weeks prior to onset. Countries of origin were: Colombia (6), Haiti, Honduras, India, Jamaica (2), Nicaragua (6), Puerto Rico (3), Trinidad and Tobago, Venezuela, and Virgin Islands. Counties reporting cases were: Brevard, Broward (5), Hillsborough, Miami-Dade (8), Monroe, Orange (2), Palm Beach (2), Pinellas, Seminole, and Volusia.

International Travel-Associated Dengue Fever Cases: Ten cases of dengue with onset in 2015 have been reported in individuals with travel history to a dengue endemic country in the two weeks prior to onset. Countries of origin were: Brazil (2), Cuba (3), Dominican Republic, Haiti, India, Jamaica, and Philippines. Counties reporting cases were: Hillsborough, Miami-Dade (5), Palm Beach, St. Johns, St. Lucie, and Seminole. One case was reported in a non-Florida resident. In 2015, four of the ten cases of dengue reported in Florida have been serotyped by PCR. Additional serotyping and strain typing are being conducted.

International Travel-Associated Malaria Cases: Fifteen cases of malaria with onset in 2015 have been reported. Countries of origin were: Angola, Cameroon (3), Egypt, Gabon, Guatemala, Haiti (3), India (2), Malawi, Nigeria, and Sudan. Counties reporting cases were: Broward (4), Charlotte, Collier, Hillsborough, Lee, Miami-Dade (3), Orange, Palm Beach (2), and Sarasota. Five of the cases were reported in non-Florida residents.

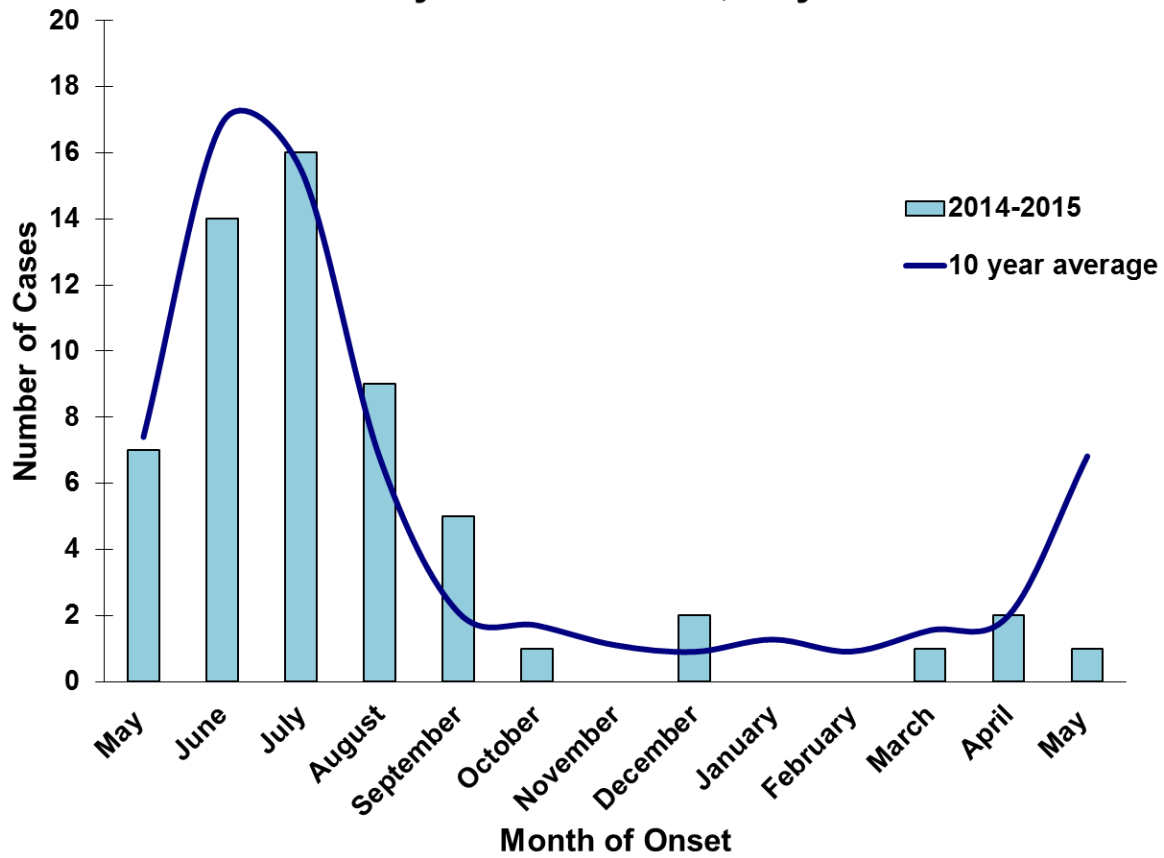
Eleven cases (73%) were diagnosed with *Plasmodium falciparum*. Four cases were diagnosed with *Plasmodium vivax* (27%).

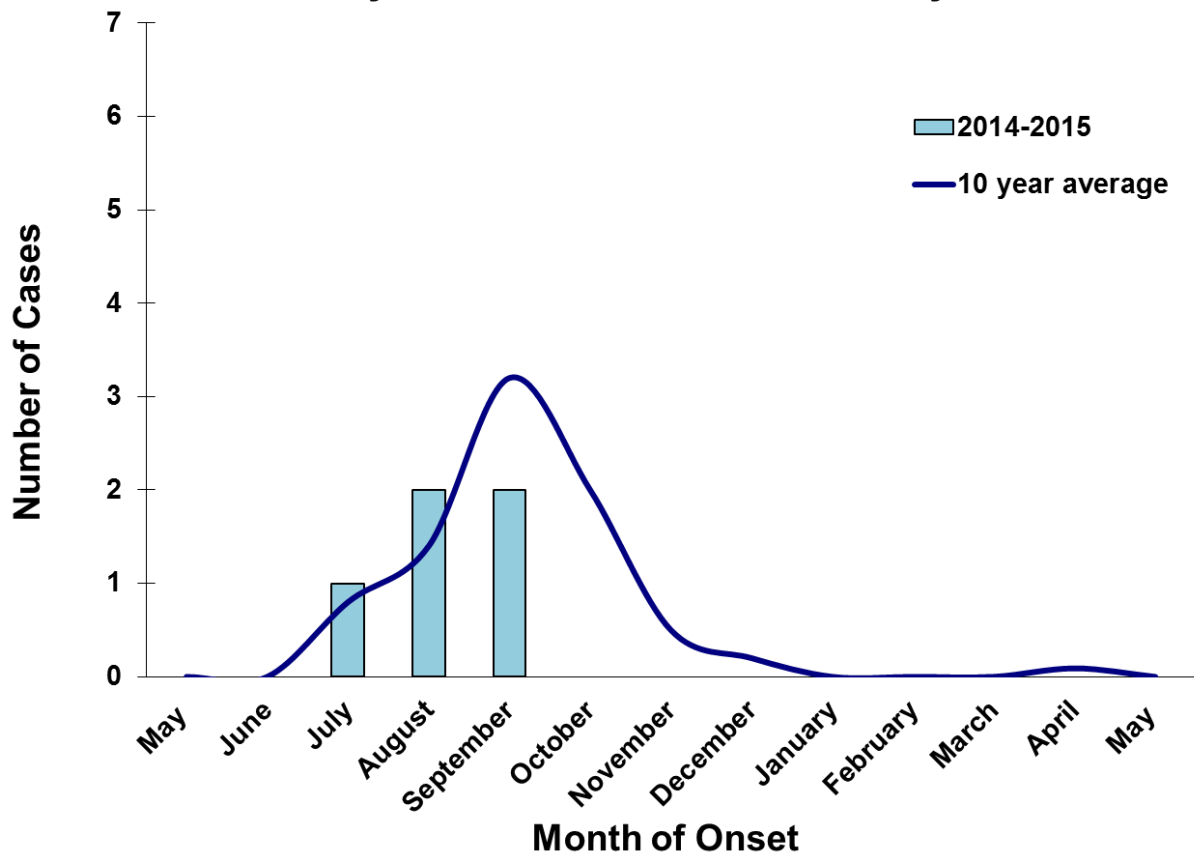

Veterinary WNV Disease in Florida, May 2014-2015



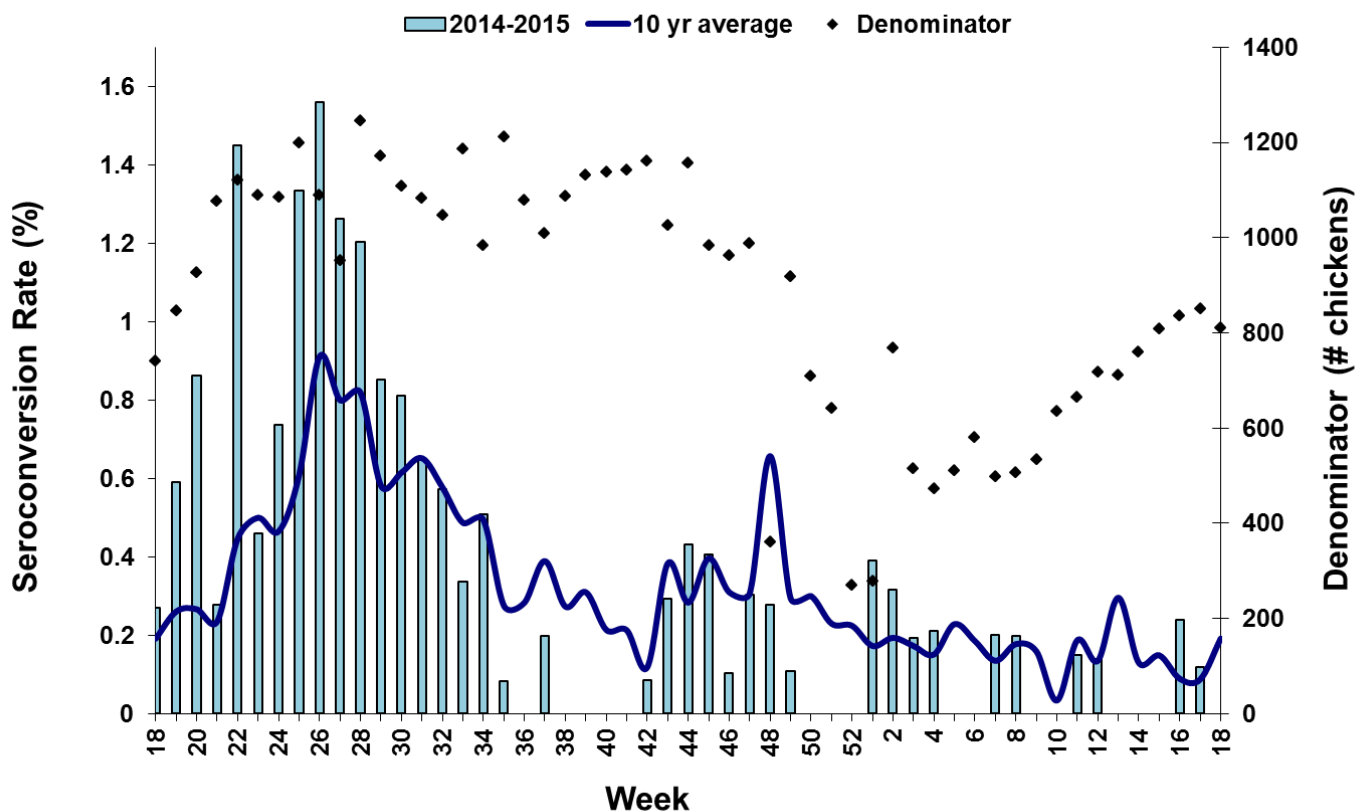
Sentinel Chickens

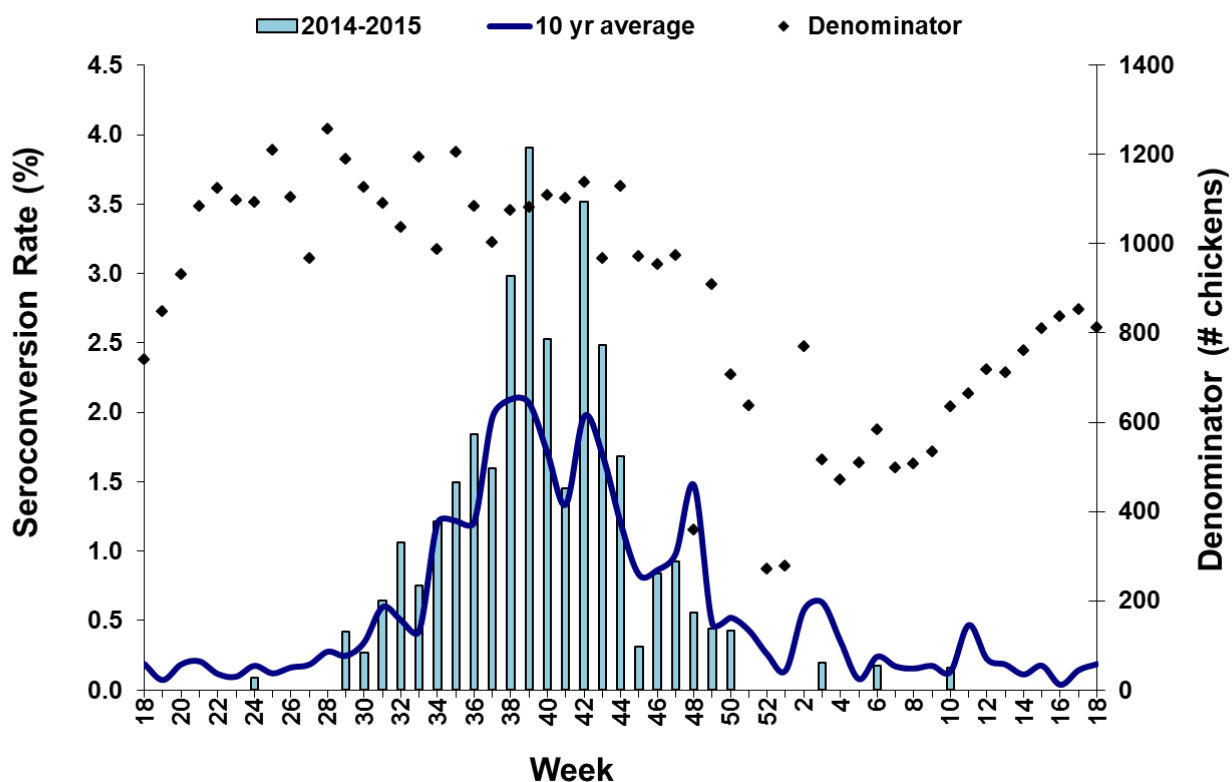
Two sentinel chickens tested positive for antibodies to EEEV this week in Flagler, and Orange Counties.

Dead Birds

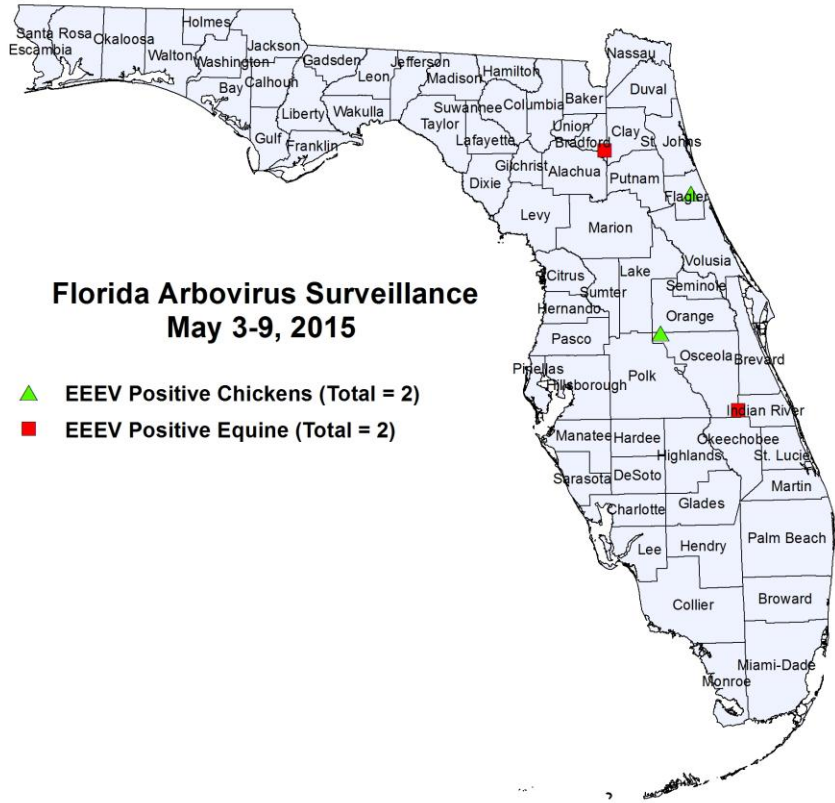
The Fish and Wildlife Conservation Commission (FWC) collects reports of dead birds, which can be an indication of arbovirus circulation in an area. This week, 12 reports representing 34 dead birds, including 3 jays, 1 raptor, and 13 doves were received from 9 counties.

In 2015, 140 reports representing a total of 347 dead birds (19 crows, 14 jays, 22 raptors, and 19 doves) were received from 38 of Florida's 67 counties. Please note that FWC collects reports of birds that have died from a variety of causes, not only arboviruses. Dead birds should be reported to www.myfwc.com/bird/.

**Case tallies included in the weekly Florida arbovirus surveillance report include confirmed and probable cases for EEE, WNV infection, SLE, dengue, and malaria by date of onset. Suspect cases are not included. Activity is mapped by county of exposure rather than county of residence. Case definitions being used in Florida are consistent with national criteria provided by the Council of State and Territorial Epidemiologists (CSTE) and may be viewed at: <http://www.floridahealth.gov/diseases-and-conditions/disease-reporting-and-management/disease-reporting-and-surveillance/index.html>

Case tallies reported by CDC do not include suspect cases and cases are reported by patient state of residence rather than where the exposure occurred. Data is provided by county health departments, Department of Health Bureau of Public Health Laboratories, Department of Agriculture and Consumer Services, mosquito control agencies, Florida Fish and Wildlife Conservation Commission, medical providers and veterinarians. Equine cases are provided by the Department of Agriculture and Consumer Services.
