INDIVIDUAL CONSIDERATION

1. Fabiane Da Silva (Examination)

Ms. Silva was present.

Ms. Da Silva submitted an application by Examination. A Portuguese translator was requested by the applicant. Ms. Elizabeth Davis from Link Translation and Typesetting Services provided translation services for Ms. Da Silva. Ms. Da Silva submitted a credential evaluation and the required 900-hour form for review. Ms. Da Silva waived the 90-day requirement pursuant to F.S. 120.60.

Following discussion, Ms. Carol Elliott made a motion to approve Ms. Da Silva's application. Ms. Kelly Jones seconded the motion which carried 5/0.
