INDIVIDUAL CONSIDERATION

1. Ramona Shires (Examination with Waiver of CNS)

Ms. Shires was present.

Ms. Shires appeared before the Council at the May 2, 2019 meeting. The Council directed Ms. Shires to provide documentation relating to the post-secondary accreditation for her education from National University of Health Science in Illinois. The Council also asked for information relating to her supervisor, Ms. Ennsmann, being equivalently prepared, as Ms. Shires' training was not completed by a Florida Licensed dietitian.

Ms. Petrosky made a motion to approve Ms. Shires' application. Ms. Linda Rex seconded the motion which carried 5/0.

2. Maria S. Decicco (Endorsement of Another State, NY)

Ms. Decicco was not present.

Ms. DeCicco applied by Endorsement of Another State License. Ms. DeCicco provided an active New York license and a copy of the New York Laws and Rules.

Ms. Carol Elliott made a motion to deny and allow seven (7) business days for withdraw of application, otherwise intent to deny will be sent. Ms. Stephanie Norris seconded the motion which carried 5/0.

3. James Conzo (Endorsement of Another State, MA)

Mr. Conzo was present.

Mr. Conzo applied by Endorsement of Another State License. Mr. Conzo provided an active Massachusetts license and a copy of the Massachusetts Laws and Rules.

An equivalent credential evaluation was provided from Josef and Silny and Associates. Council staff pulled Florida licensed supervisors verifications.

5. Ramon Torres (Application by Examination with Temporary Permit)

Mr. Torres applied by Examination with Temporary permit. Mr. Torres received a Bachelor degree from California University of Pennsylvania in Sports Management on May 07, 2016 and Received a Master's degree in Public Health from Liberty University on December 14, 2018. Mr. Torres requested to use his additional education in lieu of the 900-hour requirement as defined in 468.509, Part X.

Ms. Petrosky made a motion to deny Mr. Torres application. No second.

Ms. Petrosky made a motion to deny Mr. Torres temporary permit request. Ms. Norris seconded the motion which carried 5/0.

Ms. Petrosky made a motion to deny and allow seven (7) business days for withdraw of application, otherwise intent to deny will be sent. Ms. Elliott seconded the motion which carried 5/0.

PETITION FOR DECLARATORY STATEMENT

6. Shomika Patange

Ms. Pantange was not present.

Ms. Patange submitted a Declaratory Statement regarding Hawthorne University's accreditation. Council staff pulled and provided the Council with Hawthorne University's accreditation information.

Ms. Patange is requesting eligibility for 900-hour preceptorship to become licensed in the state of Florida.

468.509 Dietitian/nutritionist; requirements for licensure.—

(1) Any person desiring to be licensed as a dietitian/nutritionist shall apply to the department to take the licensure examination.

(2) The department shall examine any applicant who the board certifies has completed the application form and remitted the application and examination fees specified in s. 468.508 and who:

(a)1. Possesses a baccalaureate or postbaccalaureate degree with a major course of study in human nutrition, food and nutrition, dietetics, or food management, or an equivalent major course of study, from a school or program accredited, at the time of the applicant's graduation, by the appropriate accrediting agency recognized by the Commission on Recognition of Postsecondary Accreditation and the United States Department of Education; and

2. Has completed a preprofessional experience component of not less than 900 hours or has education or experience determined to be equivalent by the board; or

(b)1. Has an academic degree, from a foreign country, that has been validated by an accrediting agency approved by the United States Department of Education as equivalent to the baccalaureate or postbaccalaureate degree conferred by a regionally accredited college or university in the United States;

2. Has completed a major course of study in human nutrition, food and nutrition, dietetics, or food management; and

3. Has completed a preprofessional experience component of not less than 900 hours or has education or experience determined to be equivalent by the board.

(3) The board shall waive the examination requirement for an applicant who presents evidence satisfactory to the board that the applicant is:

(a) A registered dietitian or registered dietitian/nutritionist who is registered with the commission and complies with the qualifications under this section; or

(b) A certified nutrition specialist who is certified by the Certification Board for Nutrition Specialists or who is a Diplomate of the American Clinical Board of Nutrition and complies with the qualifications under this section.

(4) The department shall license as a dietitian/nutritionist any applicant who has remitted the initial licensure fee and has passed the examination in accordance with this section.
