After discussion, the Council did not see where Ms. Kusterman's background history would affect her ability to practice in the field of Dietetics and Nutrition.

Ms. Cooper moved to approved Ms. Kusterman's application by endorsement. Ms. Gammon seconded the motion which carried 5/0.

#### TAB 13 Seth Ellis Sr.

Mr. Ellis was present and was not represented by an attorney.

Mr. Ellis applied for licensure by endorsement of his registered dietitian status with the Commission on Dietetics Registration. Mr. Ellis' application was presented to the Council for review of his background history.

Following discussion, Ms. Cooper made a motion to approve Mr. Ellis' application upon successful completion of a Physician's Recovery Network (PRN) evaluation and compliance with their recommendation. Within the time of receiving council orders, Mr. Ellis has 60 days to contact PRN, 90 days to be evaluated, and 120 days to comply with PRN's recommendations or licensure will be denied. ## TAB 3 Proposed Language for 64B8-45.002, F.A.C., Continuing Education Approval (Exhibit Halls and Advanced Certifications)

Following discussion, the Council took the following action.

Ms. Cooper moved to open rule 64B8-45.002 for development and to accept the proposed language as followed: "(c) Time spent in exhibit halls associated with the Academy of Nutrition and Dietetics Annual Conference and Expo, and the Florida Academy of Nutrition and Dietetics Annual Symposium. Only 1 hour of credit will be awarded per symposium or meeting, up to a maximum of 2 hours per biennium." Ms. Shank seconded the motion, which carried 4/1.

Ms. Cooper moved to open rule 64B8-45.002 for development and to accept the proposed language as followed: "(d) A licensee who successfully completes a dietetic-related advanced certification exam offered or approved by the Commission on Dietetic Registration shall receive 28 hours of continuing education credit in the biennium in which the certification was awarded." Ms. Shank seconded the motion, which carried 5/0.
