ADMINISTRATIVE PROCEEDINGS

INDIVIDUAL CONSIDERATION

1. **Errol Davis (Examination with Waiver Certified by CNS)** Mr. Davis was present.

Mr. Davis applied for Licensure by Examination with Waiver for CNS. His internship was completed under the Board of Certification of Nutrition Specialists by Stanley Wallach. He obtained 1000 hours in Supervised Clinical experience ending on January 8, 1995.

9. Giovanni Andino Feliciano (Endorsement of Another State License)

Mr. Giovanni was not present.

Mr. Andino Feliciano applied by Endorsement of Another State. Mr. Andino Feliciano provided a current Puerto Rico license as well as a translated version of the Puerto Rico Laws and Rules.

Ms. Petrosky made a motion to approve Mr. Andino Feliciano's application. Ms. Norris seconded the motion which carried 4/0.

4. Matthew St. George (Endorsement of CDR)

Mr. St. George was not present.

Mr. St. George applied by Endorsement of CDR registration. Mr. St. George graduated from University of North Florida in 2017 with a Master and Bachelor of Science in Nutrition and Dietetics.

Ms. Maltass applied by Examination without a Temporary Permit. Ms. Maltass graduated from University of the Atlantic in 2008 with a Bachelor of Science in Nutrition and Dietetics from Columbia.

Ms. Norris made a motion to approve Ms. Maltass's application. Ms. Elliott seconded the motion which carried 4/0.

6. Kathryn Slater (Endorsement of CDR)

Ms. Slater was not present.

Ms. Slater applied by Endorsement with CDR. Ms. Slater graduated from University of Florida in 2008 with a Bachelor of Science in Dietetics and from Florida International University in 2016 with a Master of Science in Dietetics.

Ms. Petrosky made a motion to approve Ms. Slater's application. Ms. Norris seconded the motion which carried 4/0.

7. Tatiana Larionova (Examination with Waiver for CNS)

Ms. Larionova was present.

Ms. Larionova applied for Licensure by Examination with Waiver of CNS. Her internship was completed under the Board for Nutrition Specialists by Dr. Steve Wheeler. She obtained her 1300 hours in Supervised Clinical Experience ending November 2017.

Ms. Elliott made a motion to approve Ms. Larionova's application. Ms. Norris seconded the motion which carried 4/0.

8. Jasmyne Brown (Examination with Waiver Certified by CNS)

Ms. Brown was present.

Ms. Brown's application appeared before the Council on October 19, 2017. She was permitted a temporary permit that was issued on January 4, 2018. By Final Order issued on November 1, 2017, she needs to appear before the Council to gain permanent license.

Ms. Rex made a motion to approve Ms. Brown's application. Ms. Elliott seconded the motion which carried 4/0.

25. Kristine Boyle (Endorsement of Another State License)

Ms. Boyle was present.

Ms. Boyle applied by Endorsement of Another State License. Ms. Boyle provided a current New York license as well as a copy of the New York Laws and Rules. Council Staff has also provided an email with Elaine Butler with the Commission of Dietetic Registration (CDR) regarding her circumstances of her chosen method.

Ms. Petrosky made a motion to approve Ms. Boyle's application. Ms. Elliott seconded the motion which carried 4/0.

Following the discussion, the Council took the following action.

Ms. Norris moved to approve the list of individuals licensed by endorsement based on their Registered Dietitian status with CDR, 113 in number, beginning with Kimberly Hinnant and ending with Allison Gregg. Ms. Elliott seconded the motion, which carried 4/0. The full list of licensees are appended to these minutes. (Exhibit B)

RULES REVIEW AND/OR DEVELOPMENT

12. Rule 64B8-40.003, F.A.C., Delegation of Powers and Duties

The Board of Medicine indicated that it was interested in delegating the authority to approve AHCA exemptions from disqualification to the Council.

Ms. Guillemette provided the following Rule language:

64B8-40.003 Delegation of Powers and Duties.

- (1) Pursuant to Section 468.506, F.S., the Board delegates to the Council the following powers and duties:
- (a) Approval and denial of dietitian/nutritionist by endorsement or examination and certification of nutrition counselor by employment status as of April 1, 1988.
- (b) Issuance and denial of temporary permits to applicants for endorsement or examination.
- (c) <u>Approval and denial of requests for exemption from employment disqualification pursuant to Section 435.07.</u> Florida Statutes.
- (d) (e) Approval and denial of continuing education programs and providers of continuing education programs in dietetics and nutrition practice.
- (2) Rulemaking proposals, petitions for declaratory statement and petitions to adopt, amend or repeal rules which

relate to dietetics and nutrition practice and nutrition counseling and assessment shall be presented to the Council. The Council shall consider the matter and make recommendations to the Board as to the appropriate action to be taken.

Rulemaking Authority 468.507 FS. Law Implemented 468.506, <u>435.07</u>, FS. History—New 4-9-89, Formerly 21M-46.003, 61F6-46.003, Amended 11-16-95, Formerly 59R-40.003, Amended 6-21-01, 11-10-09.

MOTION: After discussion, Ms. Petrosky moved to approve the proposed rule language and directed counsel to proceed with rulemaking. The motion was seconded by Ms. Elliott and carried 3/0.

MOTION: Ms. Petrosky moved that a violation of this rule, or any part of this rule, would not be designated a minor violation. The motion was seconded by Ms. Elliott and carried 3/0.

MOTION: Ms. Petrosky moved the rule would not have an adverse impact on small business nor was it likely to increase regulatory costs to any entity (including government) in excess of \$200,000 in Florida within 5 years after the implementation of the rule. The motion was seconded by Ms. Elliott and carried 3/0.

13. Rule 64B9-42.001, F.A.C., Licensure by Endorsement

The Joint Administrative Procedures Committee pointed out that the newly adopted application should be incorporated by both Rules 64B8-42.001 and 64B8-42.002, F.A.C.

Rule 64B8-42.002 is being noticed and is in the process of amendment, to include the new application.

64B8-42.001 Licensure by Endorsement.

Each applicant for certification as a dietitian/nutritionist by endorsement shall file the Application for Dietitian/Nutritionist Licensure, DOH Form DH-MQA 1161, ND APP, Rev. 10/2017 07/2016, incorporated by reference, which can be accessed at http://www.floridahealth.gov/licensing-and-regulation/dietetic-nutrition, or at https://www.flrules.org/Gateway/reference.asp?No=Ref-07180, and demonstrate the following:

- (1)(a) That she or he holds registered dietitian credentials issued by the Commission on Dietetic Registration of the Academy of Nutrition and Dietetics, or
- (b) That she or he holds certification or licensure to deliver dietetic and nutritional practice in another state, district, or territory of the United States; such certification must have been granted to requirements determined to be equivalent to or more stringent than the requirements in Florida.
- (2) That she or he is not under investigation, involved in disciplinary proceedings in any jurisdiction, or otherwise disqualified by reason of violation for any act which is a violation of Chapters 456 and 468, Part X, F.S., or the rules promulgated thereunder.

Rulemaking Authority 468.507 FS. Law Implemented 456.013, 456.0635, 456.38, 468.508, 468.509, 468.511, 468.513 FS. History—New 4-9-89, Formerly 21M-48.001, 61F6-48.001, 59R-42.001, Amended 5-31-09, 2-15-10, 9-13-12, 3-5-13, 1-26-15, 9-22-15, 8-10-16.

The Council delegated Ms. Petrosky to review revisions made to the application by Council staff.

MOTION: After discussion, Ms. Petrosky moved to approve the proposed rule language and directed counsel to proceed with rulemaking. The motion was seconded by Ms. Elliott and carried 3/0.

MOTION: Ms. Petrosky moved that a violation of this rule, or any part of this rule, would not be designated a minor violation. The motion was seconded by Ms. Elliott and carried 3/0.

MOTION: Ms. Petrosky moved the rule would not have an adverse impact on small business nor was it likely to increase regulatory costs to any entity (including government) in excess of \$200,000 in Florida within 5 years after the implementation of the rule. The motion was seconded by Ms. Elliott and carried 3/0.

14. Rule 64B8-42.002, F.A.C., Licensure by Examination

This Rule went before the Board of Medicine and was approved with changes in October 2017.

The problem is that the Board of Medicine minutes state it wanted to change "may be verified" with "must document." But the phase "may be verified" never appears in the draft submitted to the Board.

Ms. Guillemette provided the following Rule language:

64B8-42.002 Licensure by Examination.

- (1) Every applicant for certification by examination shall file the Application for Dietitian/Nutritionist Licensure, DOH Form DH-MQA 1161, ND APP, Rev. <u>07/2017</u> <u>07/2016</u>, incorporated by reference, which can be accessed at http://www.floridahealth.gov/licensing-and-regulation/dietetic-nutrition or at https://www.flrules.org/Gateway/reference.asp?No=Ref-07180 and demonstrate to the Council that he or she meets one of the following:
- (a)1. Has a baccalaureate or post baccalaureate degree with a major in human nutrition, food and nutrition, dietetics, food management or equivalent major as determined by the Council from a school or program accredited by the appropriate accrediting agency recognized by the Council on Post-secondary Accreditation or its successor and the United States Department of Education; and,
- 2. Has completed 900 hours of planned and continuous supervised practice in dietetics or nutrition, or has education or experience determined to be equivalent by the Council as described in subsection (3) and (4) or (5); or
- (b)1. Has an academic degree with a major course of study in human nutrition, food and nutrition, dietetics, or food management from a foreign country, provided that degree has been validated by an accrediting agency approved by the U.S. Department of Education as equivalent to the baccalaureate or post baccalaureate degree conferred by a regionally accredited college or university in the United States; and,
- 2. Has completed 900 hours of planned and continuous supervised practice in dietetics or nutrition, or has education or experience determined to be equivalent by the Council as described in subsection (3) and (4) or (5).
- (2) An equivalent major as referenced in 468.509(2)(a)1., F.S. mentioned in subparagraph 64B8 42.002(1)(a)1., F.A.C., shall be a course of study specially designed to prepare an individual to integrate and apply principles of nutrition under varying conditions of health, social, physical, psychological, and economic status to the appropriate care, nourishment and education of individuals or groups throughout the life cycle. Any major must include at least thirty semester hours covering human nutrition, nutrition in health and disease, nutrition education and counseling, food science, nutrition in the community, and administration of food service or nutrition programs.
- (3) A documented and planned supervised practice experience component in dietetic and nutrition practice of not less than 900 hours shall provide the applicant with a broad spectrum of experiences in dietetics and nutrition. Such practice shall include:
- (a) A minimum of 200 hours in Clinical Nutrition that provides competency in the following areas: Examples of clinical nutrition practical experience are generally acquired in a hospital or other acute or chronic care setting.
 - 1. Assessment of nutritional status for both complex and uncomplicated medical conditions;
 - 2. Design and implementation of nutrition care plans;
 - 3. Application of medical nutrition therapy for treatment of disease and trauma;
- 4. Selection, implementation and evaluation of nutritional support, such as medical food, enteral and parenteral nutrition regimens;
 - 5. Counseling and nutrition education of patients on dietary modifications, including techniques that demonstrate

integration of theoretical training, psychological and behavioral aspects of interpersonal relationships, documentation of appropriate interventions, and proper decision-making;

- 6. Performance of basic physical assessments;
- 7. Quality assurance;
- 8. Menu planning for target populations to meet nutritional guidelines and special dietary needs;
- 9. Development or modification of recipes or formulas;
- 10. Food safety and sanitation.
- (b) A minimum of 200 hours in Community Nutrition that provides competency in the following areas: Examples of Community Nutrition practical experience generally acquired within a community or public helath program or HMO.
- 1. Screening/assessment of nutritional status of the population or community group, including counseling techniques that demonstrate integration of theoretical training, psychological and behavioral aspects of interpersonal relationships, documentation of appropriate interventions, and proper decision-making.
 - 2. Provision of nutritional care for people of diverse cultures and religions across the lifespan;
 - 3. Development, evaluation or implementation of community based health promotion program(s);
 - 4. Nutrition surveillance and monitoring of the population or community group;
 - 5. General health assessment, e.g. blood pressure and vital signs;
 - 6. Development and review of educational materials for the target population; and,
 - 7. Development of food and nutrition policy for the population or community group.
- (4) The supervisor/preceptor of the supervised practice experience shall be a dietitian/nutritionist licensed under Part X, Chapter 468, F.S., or a healthcare provider with training that is substantially equalivant to a license dietitian/nutritionist, or equivalently prepared, if supervised practice was in another jurisdiction. Although many dietetics and nutrition programs include the 900 hour component in their baccalaureate or post graduate training, the Council will recognize an individual preceptorship when the following requirements are met:
 - (a) The student has met the academic requirements of Sections 468.509(2)(a)1., (b)1., or (b)2., F.S.;
 - (b) The supervisor/preceptor meets the requirement of this rule;
- (c) The supervisor/preceptor shall provide written objectives and a planned experience component that meets the requirements of this rule prior to the student beginning the preceptorship;
- (d) The preceptor shall be available to the student at all time the student is performing dietetics and nutrition services for patients.
- (5) As an alternative to the supervised practice requirement as explained in (3) and (4) of this rule, an applicant may provide documentation of education or experience equivalent to the 900 hours of preprofessional experience.
- (6)(5) The examination to be used for licensure is the Registration Examination for Dietitians from the Commission on Dietetic Registration, unless the person is qualified for exemption by Section 468.509(3), F.S. The number of test questions each examinee answers correctly shall be transferred to a scale that ranges from 1 to 50 with a minimum passing score being a scaled score of 25.
- (7)(6) When an applicant is certified to sit for the examination or re-examination, it is the applicant's responsibility to complete the examination process with the national vendor. In compliance with the Americans for Disabilities Act, any applicant requesting special accommodations shall comply with the Department of Health's Rule 64B-1.005, F.A.C.
