INDIVIDUAL CONSIDERATION

1. Blanca R. Alvarez (Endorsement of Another State License, PR)

Ms. Alvarez was present.

Ms. Alvarez applied by Endorsement of Another State License. Ms. Alvarez provided an active Puerto Rico license and the Puerto Rico Laws and Rules.

Ms. Elliott made a motion to approve Ms. Alvarez's application. Ms. Rex seconded the motion which carried 3/0.

17. Patricia Murphy, Endorsement of Another State, MA

Ms. Murphy was present.

Ms. Murphy applied by Endorsement of Another State License. Ms. Murphy provided an active Massachusetts license and the Massachusetts Laws and Rules.

Ms. Petrosky made a motion to approve Ms. Murphy's application. Ms. Elliott seconded the motion which carried 3/0.

2. Kimberly Kirschner (Examination with Waiver of CNS)

Ms. Kirschner was present.

Ms. Kirschner applied by Examination with Waiver of CNS Certification. Council staff pulled license verifications for her supervisors, Ms. Lipski, Ms. Swetz and Ms. Schroeder; who are licensed Dietitians in Maryland. Ms. Kirschner provided her 900 Hours form. She received a Master's degree in Nutrition and Integrative Health from Maryland University of Integrative Health on August 13, 2018.

Ms. Elliott made a motion to approve Ms. Kirschner's application. Ms. Rex seconded the motion which carried 3/0.

3. Ramona Shires (Examination with Waiver of CNS)

Ms. Shires applied by Examination with Waiver of CNS Certification. Council Staff pulled license verifications for her supervisor, Ms. Ennsmann; who is a licensed Chiropractor in Illinois. Ms. Shires requested her application remain "as is". Ms. Shires received a Doctorate of Naturopathic Medicine degree from National University of Health Science in Illinois on August 17, 2018.

Council requested Ms. Shires provide additional documentation of education accreditation and supervision documents.

18. Continuing Education Provider Approval

Nicole McFadden was present.

University of Western States in Portland, Oregon reached out to the Council office regarding their registration for Continuing Education credit for UWS Summer in December 2019 - Live in

Maui, Hawaii. This course has been approved with the Florida Chiropractic Board and CEBroker had the course listed for Dietetics approval.

Ms. Nicole McFadden, with the University of Western States, contacted the council office regarding the approval for Dietetics and Nutrition and provided documentation of the course. She believes this course would meet the requirements of our rule for Continuing Education Approval.

Ms. Petrosky requested review of provided documentation to determine if this course meets requirements for continuing education credit per 64B8-45.002, F.A.C.

64B8-45.002 Continuing Education Approval.

(1) Continuing education credit shall be awarded for educational experiences received through the following methods:

3. College courses from an approved graduate or undergraduate program which is accredited by an accrediting agency approved by the United States Department of Education or courses approved by any Board within the Division of Medical Quality Assurance of the Florida Department of Health which relate to the maintenance of skills necessary for the safe and competent practice of dietetics and nutrition services, the licensee shall receive 15 continuing education credits for each semester hour of the course.

(4) Acceptable subject matter for continuing education programs include:

(a) Updates of knowledge and skills in dietetics and nutrition practice for competent performance beyond the minimum requirements for licensure;

(b) Food preparation that focuses on nutritional value;

(c) Nutrition with specialized populations;

(d) Assessment and treatment of various dietary and nutritional disorders;

(e) Innovative marketing strategies in dietetics and nutrition practice;

(f) Food service systems management.

(5) Nonacceptable subject matter for continuing education programs include:

(a) Professional association business meetings or delegate reports;

(b) Menu planning;

(c) Food service sanitation;

(d) Cooking demonstrations;

(e) Sales presentation on a company's new product;

(f) Programs intended for or by the lay public.
