INDIVIDUAL CONSIDERATION

1. Karoline Pereira Silva (Application by Examination)

Ms. Pereira Silva was present.

Ms. Pereira Silva submitted an Application by Examination. She graduated from Cruzeiro Do Sul University in Brazil with a bachelor's degree with a completion of 24 semester credit hours of additional undergraduate study in July of 2011. Ms. Pereira Silva also graduated from Sao Judas Tadeu University in Brazil with a bachelor's degree in Nutrition in January of 2005. A credential evaluation was received from Josef Silny & Associates, Inc. with a course-by-course evaluation of Ms. Pereira Silva's undergraduate study at Sao Judas Tadeu University as well as Cruzeiro Do Sul University in terms of U.S. courses, semester credit hours and grades.

2. Shawna Kunselman (Application by Examination with Waiver)

Mrs. Kunselman submitted an Application by Examination with Waiver, certified by CNS. Council staff has pulled license verifications for her supervisor, Dr. Dane Mosher who is licensed in Texas with a Full Medical License. He is also a licensed practitioner with extensive training in dietary and nutritional training.

3. Aymee Perez (Application by Examination with Waiver)

Ms. Perez was not present.

Ms. Perez holds a CNS Certification and is applying by the method that allows wavier of the CDR examination. Council staff has pulled license verifications for her supervisors Jaime Schehr and Linda Fleming. Jaime Schehr is a certified Dietician Nutritionist in the State of New York as well as a Licensed Naturopathic Physician in the State of Connecticut. Ms. Schehr is also a Registered Dietician through the Commission on Dietetic Registration. Linda Fleming is a Licensed Dietician in the State of Connecticut who is also certified as a Certified as a Certified Nutrition Specialist. Ms. Fleming is also ASCP certified as a Medical Technologist. Ms. Perez has provided her 900 Hour forms and her Certified Nutritionist Specialist certification. She received a Master of Science in Human Nutrition from the University of Bridgeport in Bridgeport, Connecticut on August 10, 2019.

Ms. Stephanie Norris made a motion to approve Ms. Perez's application. Ms. Carol Elliott seconded the motion which carried 4/0.

4. Rebecca Washuta (Application by Examination with Waiver)

Ms. Washuta was present.

Ms. Washuta holds a CNS Certification and is applying by the method that allows wavier of the CDR examination. Council staff has pulled the license verification for her supervisor Galit Safirstein Zarco. Galit Safirstein Zarco is a certified Dietician Nutritionist in the State of Florida. Ms. Washuta has provided her 900 Hour forms and her Certified Nutritionist Specialist certification. She received a Master of Science in Applied Nutrition from the University of New England in Portland, Maine on December 10, 2018.

Ms. Stephanie Petrosky made a motion to approve Ms. Washuta's application upon review of the additional documents attached mentioned on her 900-Hour supervised experience verification form. Ms. Washuta was asked to provide the additional documentation to the Chair for review prior to issuing a license. Ms. Carol Elliott seconded the motion which carried 4/0.
