Minutes

1 Licensure by Examination, the supervisor/preceptor of the supervised practice experience
2 shall be a dietitian/nutritionist licensed under *Part X, Chapter 468, F.S.*, or equivalently
3 prepared, if supervised practice was in another jurisdiction. Ms. Elliott questioned Ms. Folsom
4 about the breakdown of her 1000 hours that were completed while obtaining her CNS
5 credentials.

6 Ms. Folsom addressed the Council stating that she completed 250 hours in nutrition
7 assessments, 550 hours in nutrition which include 100 hours in intervention, 100 hours in
8 education, 250 hours in counseling and 100 hours in management. Ms. Folsom also
9 completed 200 hours that included both evaluations and nutrition monitoring.

10 Ms. Rex inquired about options available to assist Ms. Folsom with getting her application
11 approved. Ms. Guillemette proposed that the Council could approve Ms. Folsom's application
12 contingent upon the approval of the waiver of variance by the Board of Medicine or deny Ms.
13 Folsom's application.

14 Mr. Hall stated the Council would need a basis to deny the application and suggested that the
15 Council do a conditional approval based upon the decision of the Board of Medicine.
16 Ms. Norris acknowledges Ms. Folsom's experience and expressed her concern about
17 Physician preceptors for Dietitians and Nutritionists.

18 Ms. Petrosky presented the options for Ms. Folsom's application which included; to deny the
19 application based off of the documentation that the applicant submitted, have the applicant
20 withdraw her application voluntarily or approve Ms. Folsom's application contingent upon the
21 approval of the waiver of variance by the Board of Medicine.

22 Linda Rex moved to approve the application contingent upon the approval of the waiver of
23 variance by the Board of Medicine. Stephanie Norris seconded the motion, which carried 5/0.

24 **2. Nancy Rodriguez-Suarez (Examination)**

25 Ms. Rodriguez-Suarez was present.

26 Ms. Rodriguez-Suarez applied for licensure by examination. Her application was presented to
27 the Council for review of her education and 900 pre professional hours. Ms. Rodriguez-Suarez
28 received her education in Colombia and was also foreign trained. Ms. Rodriguez-Suarez
29 completed her 900 hours of pre professional hours in Florida.

30 Ms. Petrosky asked Ms. Rodriguez-Suarez about her experience. Ms. Rodriguez-Suarez
31 mentioned that her background training consisted of working as a Nutritionist from 1989-1991,
32 working for a high risk hospital in Nutritional Support from 1991-1992, Pediatric Nutritional
33 Support from 1992-1994 and Pediatric Nutritional Support from 1994-1999 Ms. Rodriguez-
34 Suarez then relocated to Florida where she completed her 900 hours. Ms. Rodriguez-Suarez
35 completed community and clinical hours which consisted of shadowing the Nutritionist with
36 high risk clients, completing assessments and recommendations.

37 Pursuant to Florida Administrative Code 64B8-42.002, Ms. Rodriguez Suarez meets the
38 necessary requirements for approval to sit for the licensure exam in the state of Florida.

1 Ms. Norris moved to approve Ms. Rodriguez-Suarez's application for licensure by
2 examination. Ms. Elliott seconded the motion, which carried 5/0.

3 **3. Erica Marie Soucier (Examination)**

4 Ms. Soucier was present.

5 Ms. Soucier applied for licensure by examination. Her application was presented to the
6 Council for review of her 900 pre professional hours. Ms. Soucier used a non-traditional
7 pathway to obtain her hours.

8 Ms. Petrosky stated that Ms. Soucier had a non-traditional route for completing her 900 hours.
9 Ms. Soucier stated that she was the first graduate from the University of Miami Nutrition
10 program which is why her hours are a bit non-traditional.

11 Ms. Norris congratulated Ms. Soucier on her accomplishment(s).

12 Pursuant to Florida Administrative Code 64B8-42.002, Ms. Soucier meets the necessary
13 requirements for approval to sit for the licensure exam in the state of Florida.

14 Ms. Elliott moved to approve Ms. Soucier application for licensure by examination. Ms.
15 Gammon seconded the motion, which carried 5/0.

16 **4. Austin Richardson (Endorsement of Registered Dietitian Status)**

17 Mr. Richardson was present.

18 Mr. Richardson applied for licensure by endorsement of his Registered Dietitian Status with
19 CDR. His application was presented to the Council for review of his affirmative answer to the
20 criminal history question on his application.

21 Ms. Petrosky asked Mr. Richardson to explain where he was currently employed and his job
22 duties. Mr. Richardson stated that he currently works for Bayfront Springhill in Springhill, FL as
23 a Signified Clinical Dietitian. Mr. Richardson has 9 employees working under him for Food
24 Service Management. Mr. Richardson oversees the entire hospital where he has food service
25 responsibilities, monitors Telemetry, Med Search and the Intensive Care Unit.

26 Ms. Petrosky stated that under the Florida law, hospital Dietitians are exempt from being
27 licensed.

28 Ms. Norris congratulated Mr. Richardson on his turn around and success. Ms Norris stated
29 that she personally knows a few of the individuals that wrote Mr. Richardson's letters of
30 recommendation.

31 Ms. Petrosky congratulated Mr. Richardson on his turn around and success.
32 Pursuant to Florida Administrative Code 64B8-42.001, Mr. Richardson meets the necessary
33 requirements for approval of licensure in the state of Florida.

34 Ms. Norris moved to approve Mr. Richardson's application for licensure by endorsement of his
35 Registered Dietitian status with CDR. Ms. Gammon seconded the motion, which carried 5/0.

1 **5. Ms. Yamuna Brahakmanage (Examination)**

2 Ms. Brahakmanage was not present.

3 Ms. Brahakmanage applied for licensure by examination. Her application was presented to the
4 Council for review of her education and 900 pre professional hours. Ms. Brahakmanage
5 received her education in Sri Lanka and was also foreign trained. Ms. Brahakmanage
6 completed her 900 hours of pre professional hours in Florida.

7 Ms. Petrosky stated that Ms. Brahakmanage provided the evaluation of her transcript which
8 presents that her educational competency for the practice of nutrition is adequate. Ms.
9 Petrosky stated that Ms. Brahakmanage has experience in volunteering hours as a Nutrition
10 Educator and has the correct documentation for her 900 pre professional hours.

11 Ms. Petrosky asked the staff for any additional input on Ms. Brahakmanage's application. Ms.
12 Adams verified that Ms. Brahakmanage's application is complete according to the state of
13 Florida standards.

14 Pursuant to Florida Administrative Code 64B8-42.002, Ms. Brahakmanage meets the
15 necessary requirements for approval to sit for the licensure exam in the state of Florida.

16 Ms. Elliott moved to approve Ms. Brahakmanage's application for licensure by examination.
17 Ms. Rex seconded the motion, which carried 5/0.

19 **6. List of Applicants Approved to Sit for the Examination**

20 Following the discussion, the Council took the following action.

21 Ms. Gammon moved to ratify the list of individuals approved to sit for the examination
22 beginning with Lorena Carolina Farias and ending with Janet Garces. Ms. Elliott seconded the
23 motion, which carried 5/0. The full list of examination candidates are appended to these
24 minutes.

25 **7. List of Licensees Certified for Licensure by Endorsement of Registered Dietitian**
26 **Status**

27 Following the discussion, the Council took the following action.

28 Ms. Elliott moved to approve the list of individuals licensed by endorsement based on their
29 Registered Dietitian status with CDR, beginning with Karen Lynn Atkins and ending with Chih-
30 Ming Sun. Ms. Norris seconded the motion, which carried 5/0. The full list of licensees are
31 appended to these minutes.

32 **RULES REVIEW AND/OR DEVELOPMENT**

33 **8. Rule 64B8-42.002 Licensure by Examination**

Minutes

1 Ms. Guillemette stated that Mr. Tellachia is the counsel for the Board of Medicine and the
2 Bureau Chief for the Attorney General's office. Ms. Guillemette stated that Mr. Tellachia
3 recommends that Medical Doctors and Doctors of Osteopathic Medicine should be considered
4 as preceptors contrary to what the Dietetics and Nutrition rule 64B8-42.002 (4) currently reads.
5 Florida Administrative Code 64B8-42.002 (4) reads: "The supervisor/preceptor of the
6 supervised practice experience shall be a dietitian/nutritionist licensed under Part X, Chapter
7 468, F.S., or equivalently prepared, if supervised practice was in another jurisdiction."

8 Ms. Guillemette stated that right now this rule says that if you are in the state of Florida, the
9 supervisor must be a Dietitian or Nutritionist, but if the individual is in another jurisdiction, but
10 not licensed in the state of Florida, they will not meet the qualifications to be a preceptor.
11 Mr. Tellachia would like to change the language in the said rule to include Medical Doctors
12 and Doctors of Osteopathic Medicine. Ms. Guillemette stated that "equivalently prepared"
13 should apply to supervised practice in the state of Florida as well as in another jurisdiction.
14 Ms. Guillemette gave suggestions to the Council on the language to use for the rule change
15 and also suggested that the Council open the language for development.

16 Ms. Petrosky stated that the language change for rule 64B8-42.002 (4) should be opened for
17 development under the timeline and process for rulemaking.

18 Ms. Elliott stated that she does know medical doctors and doctors of Osteopathic Medicine
19 that have intense nutritional background and those that do not. Ms. Elliott questioned how
20 would one identify that a doctor meets the necessary requirements to be a preceptor and if
21 this information would be added to the language. Ms. Petrosky stated that using certain
22 verbiage or language that would help specify or requesting documentation be provided would
23 probably help. Ms. Guillemette recommended opening the rule for development and coming
24 up with language appropriate to send to the Board of Medicine.

25 Ms. Norris asked if there was a board certified program in Nutrition and Dietetics or additional
26 training certification available for Doctors to obtain. Ms. Norris suggested that if there are such
27 programs, they should be added to the proposed language.

28 Ms. Elliott moved to open rule 64B8-42.002 (4) language proposal for development. Ms.
29 Gammon seconded the motion, which carried 5/0.

30 **9. Rule 64B8-44.003 Disciplinary Guidelines**

31 Ms. Guillemette stated there was a statutory change earlier in the year which changed *Florida*
32 *Statute 456.072 (00)* and added additional actions for which disciplinary actions could be
33 taken. The Department of Health has an umbrella statute which covers all of the professions
34 under which the health board operates. The umbrella statute is 456. Ms. Guillemette stated
35 that the statement "Willingly failing to comply" was added to the rule and happens when
36 individuals have insurance and they are being charged on top of their insurance. If this action
37 takes place in such a frequency as to indicate a general business practice, if it's contrary to the
38 law then there could be a violation. Ms. Guillemette stated that because there is a possible
39 violation that is not listed in the guidelines, the guidelines need to be updated to have a
40 potential penalty for said violation. Ms. Guillemette gave suggestions as to what language to
41 use and asked the Council to come up with an appropriate penalty for those that violate this
42 statute.

1 Ms. Petrosky asked Ms. Guillemette for further clarification on the violation.

2 Ms. Guillemette referred to the disciplinary guidelines subsection “v” and suggested the
3 Council consider using something consistent with the following as a penalty for future
4 violations: “For the first offense, one year of probation, with conditions and a \$2,500.00 fine.
5 For the second offense, one year of suspension and a \$5,000.00 fine.”

6 Ms. Elliott moved to open the rule for development with the approved language. Ms. Gammon
7 seconded the motion, which carried 5/0.

8 Ms Norris moved to recommend that the language suggested by the Council be presented to
9 the Board of Medicine. Ms. Elliott seconded the motion which carried 5/0.

10 Ms. Elliott moved that the proposed rule amendment for Florida Administrative Code 64B8-
11 44.003 would not have an adverse impact on small businesses and would not be likely to
12 directly or indirectly increase regulatory cost to any entity (including government) in excess of
13 \$200,000.00 in the aggregate in Florida within 1 year after the implementation of the rule. Ms.
14 Gammon seconded the motion, which carried 5/0.
