**TAB 3 Proposed Language for 64B8-45.002, F.A.C., Continuing Education
Approval**

Following the discussion, the Council took the following action.

Proposed language: “(c) Time spent in exhibit halls associated with the Academy of Nutrition and Dietetics Annual Conference and Expo, and the Florida Academy of Nutrition and Dietetics Annual Symposium. Only 1 hour of credit will be awarded per symposium or meeting, up to a maximum of 2 hours per biennium.”

Ms. Rarback was raised the concern of naming specify conferences and suggested using criteria instead of listing the names of conferences. The council agreed.

Ms. Cooper moved to table the proposed language for 64B8-45.002(c) and to continuing with rulemaking to add criteria to the language. Ms. Shank seconded the motion, which carried 5/0.

Ms. Shank and Ms. Guillemette will continue to work on the language. Staff will provide Ms. Shank and Ms. Guillemette the criteria from other professions as an example. Ms. Stone offered to assist.

Proposed language :“(d) A licensee who successfully completes a dietetic-related advanced certification exam offered or approved by the Commission on Dietetic Registration shall receive 28 hours of continuing education credit in the biennium in which the certification was awarded.”

Ms. Cooper moved that the wording be changed from “exam” to “examination” and the rest of the wording is proposed for approval. Ms. Rarback seconds the motion, which carried 5/0.

Ms. Cooper moved that the proposed changes to rule 64B8-45.002 would not have an adverse impact on small business. Ms. Rarback seconded the motion, which carried 5/0.

Ms. Cooper moved that the proposed changes to rule 64B8-45.002 would not be likely to directly or indirectly increase regulatory cost to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. Ms. Gammon seconded the motion, which carried 5/0.

Ms. Cooper moved to table this tab until language for subsection (c) is complete. Ms. Shank seconded the motion, which carried 5/0.
