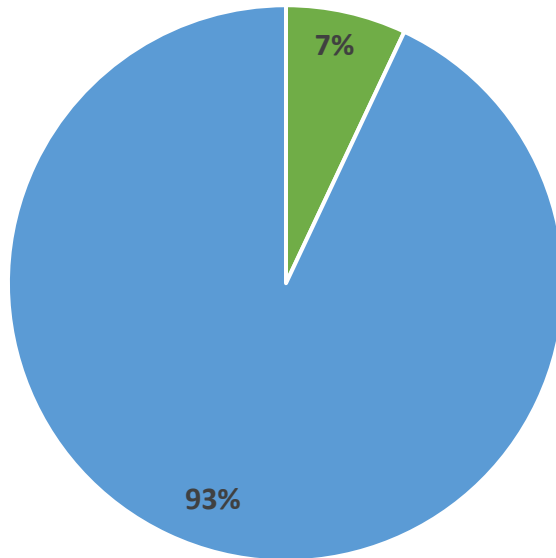

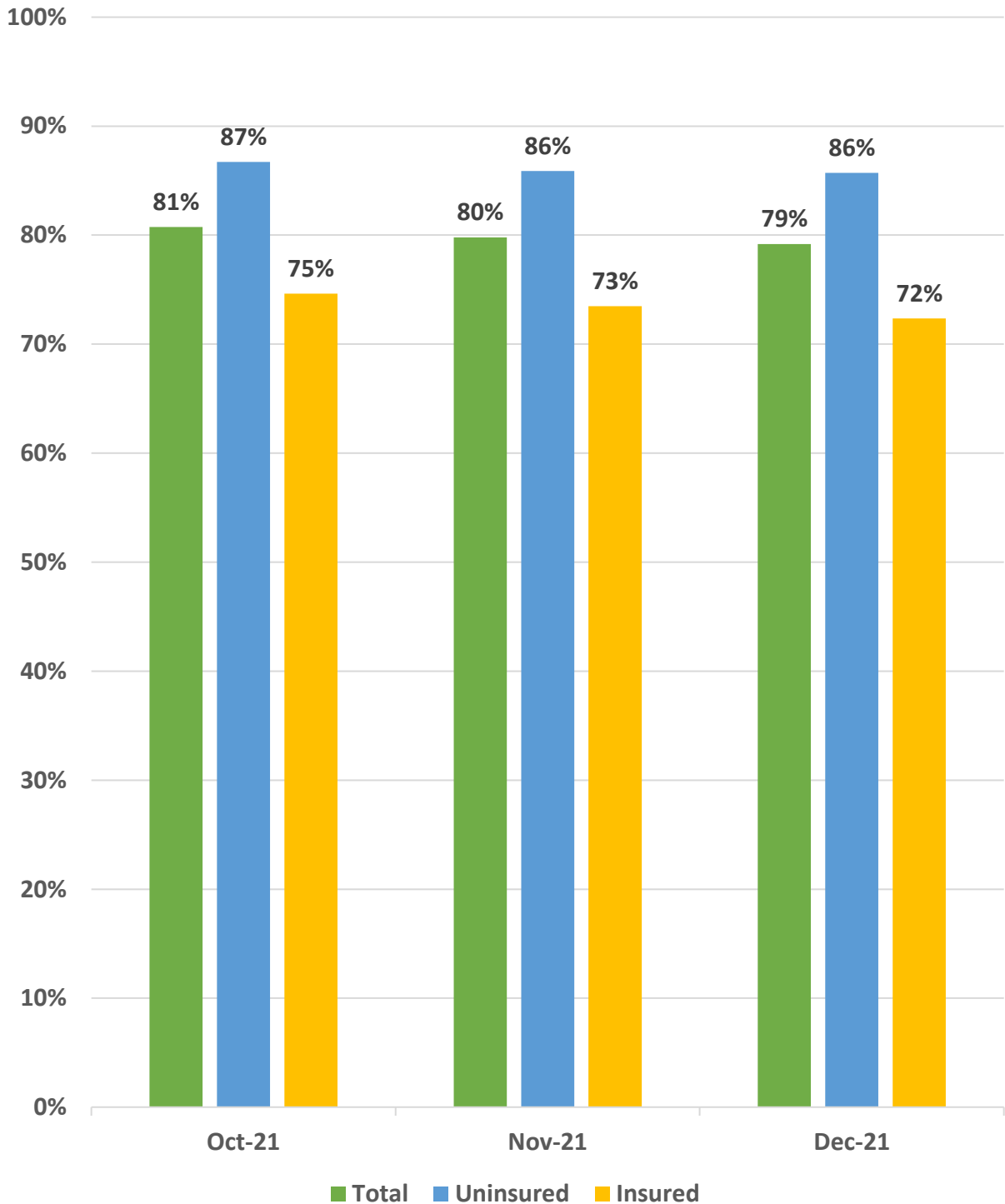

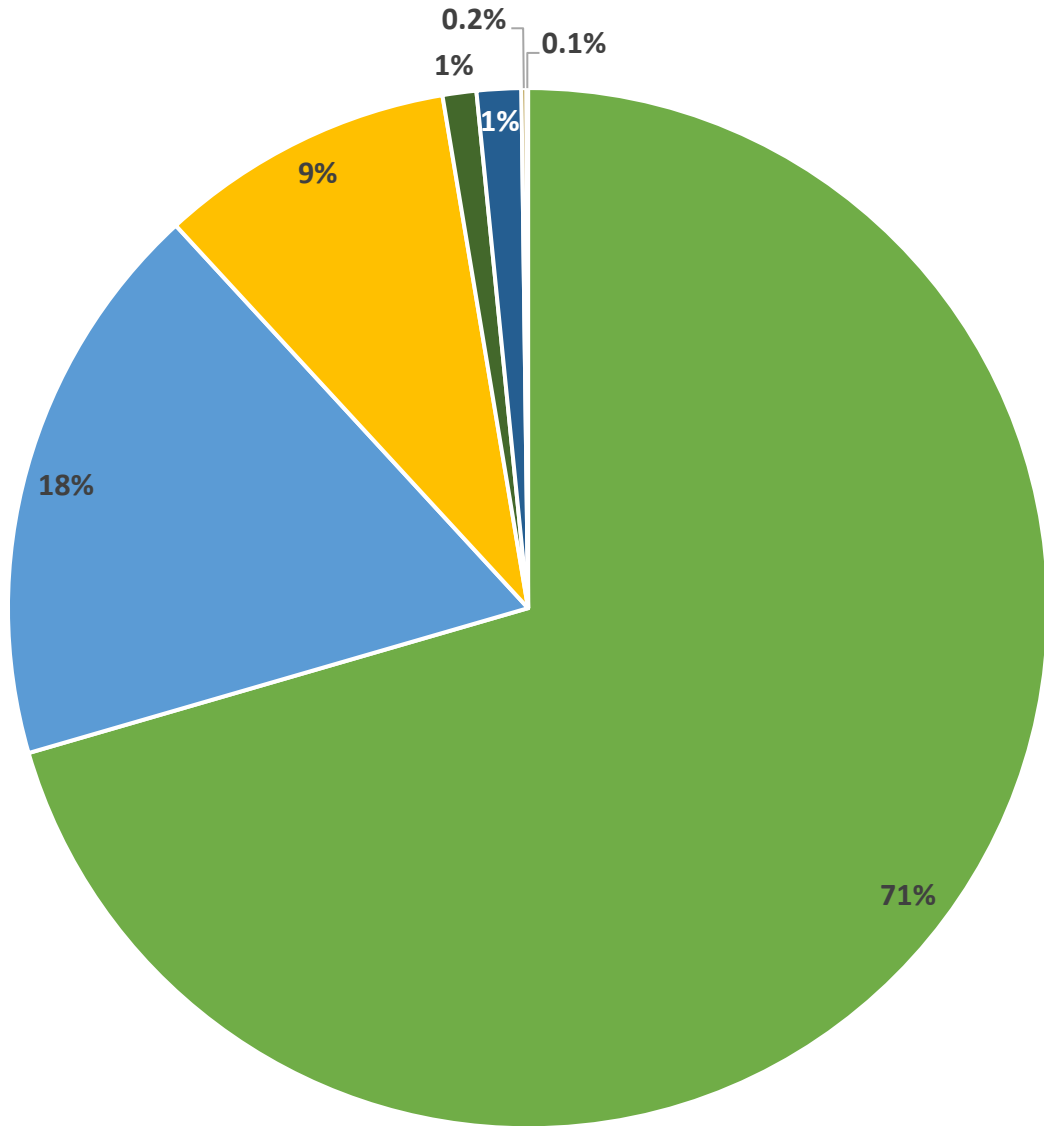

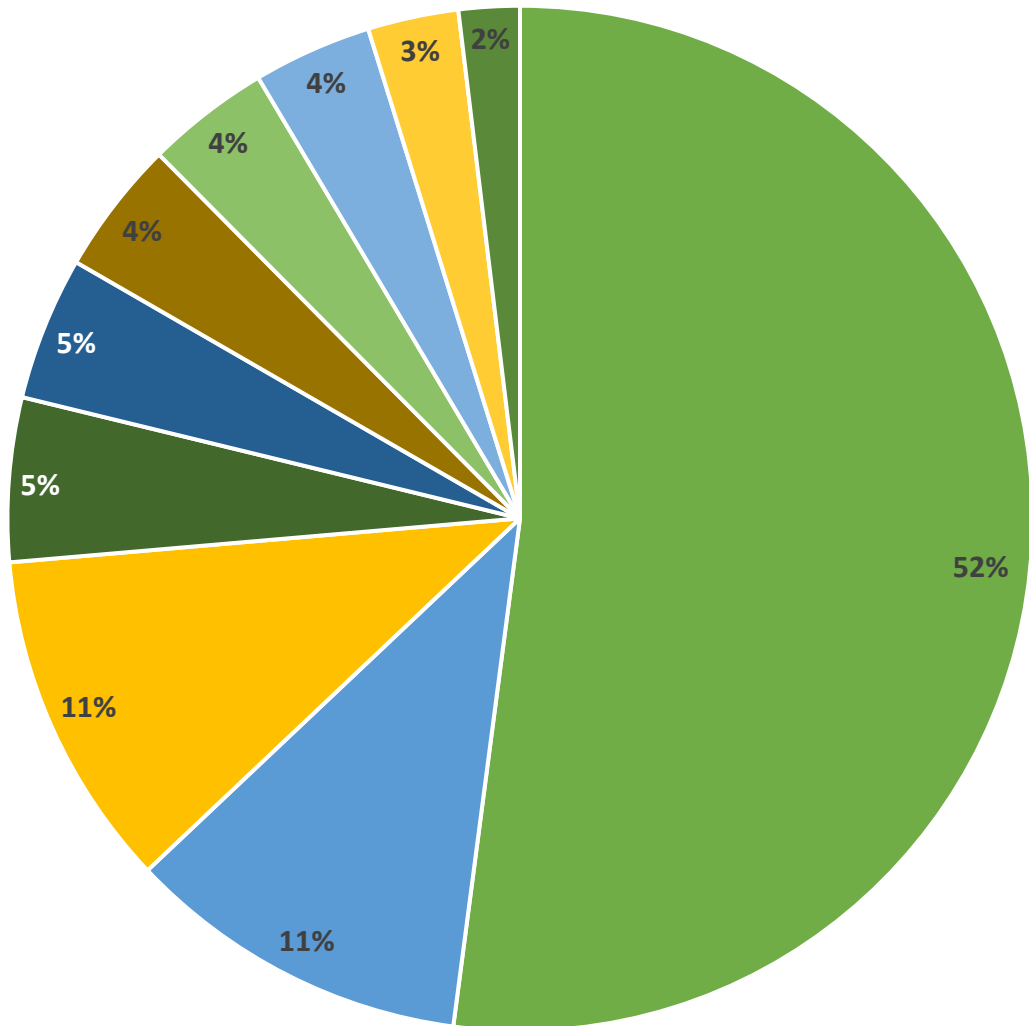
ADAP PRESCRIPTION DISPENSES AND EXPENDITURES

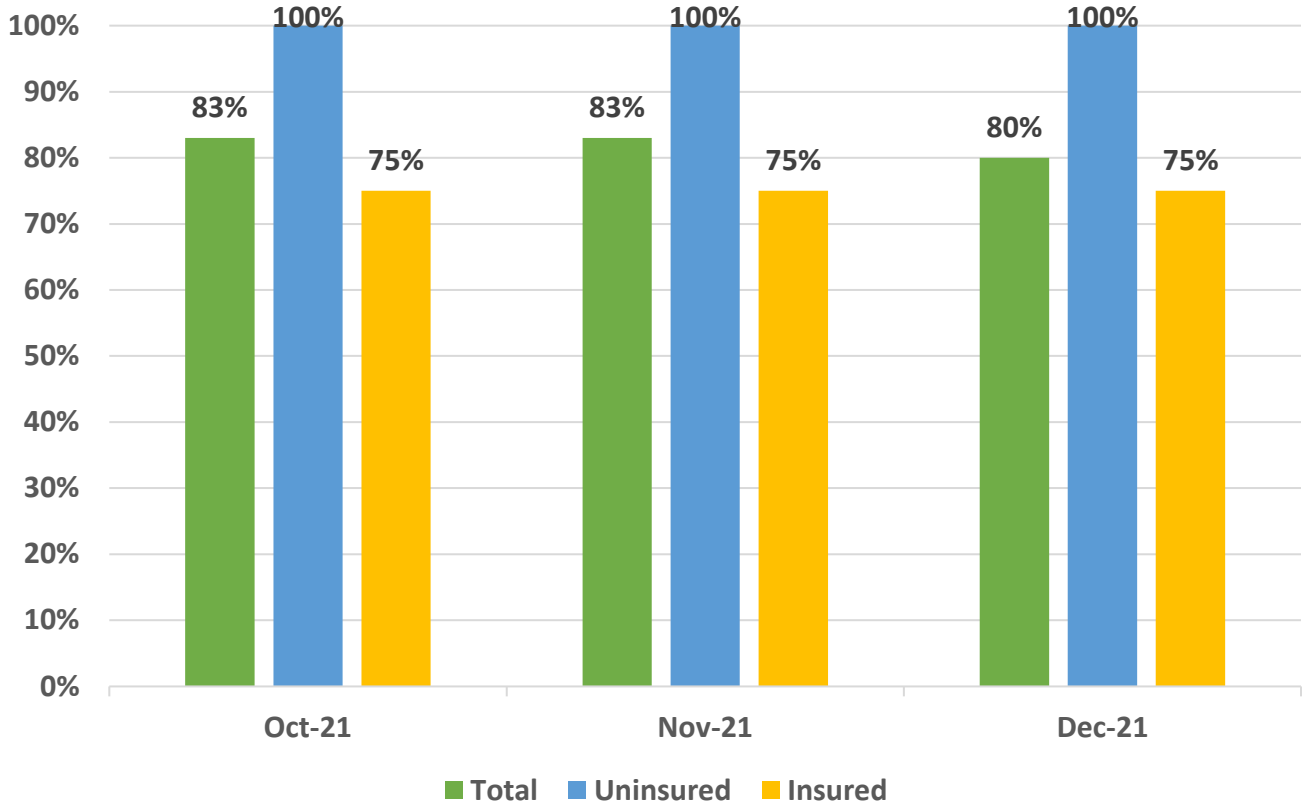
RYAN WHITE GY 2021-2022 QUARTER 3 VIRAL LOAD



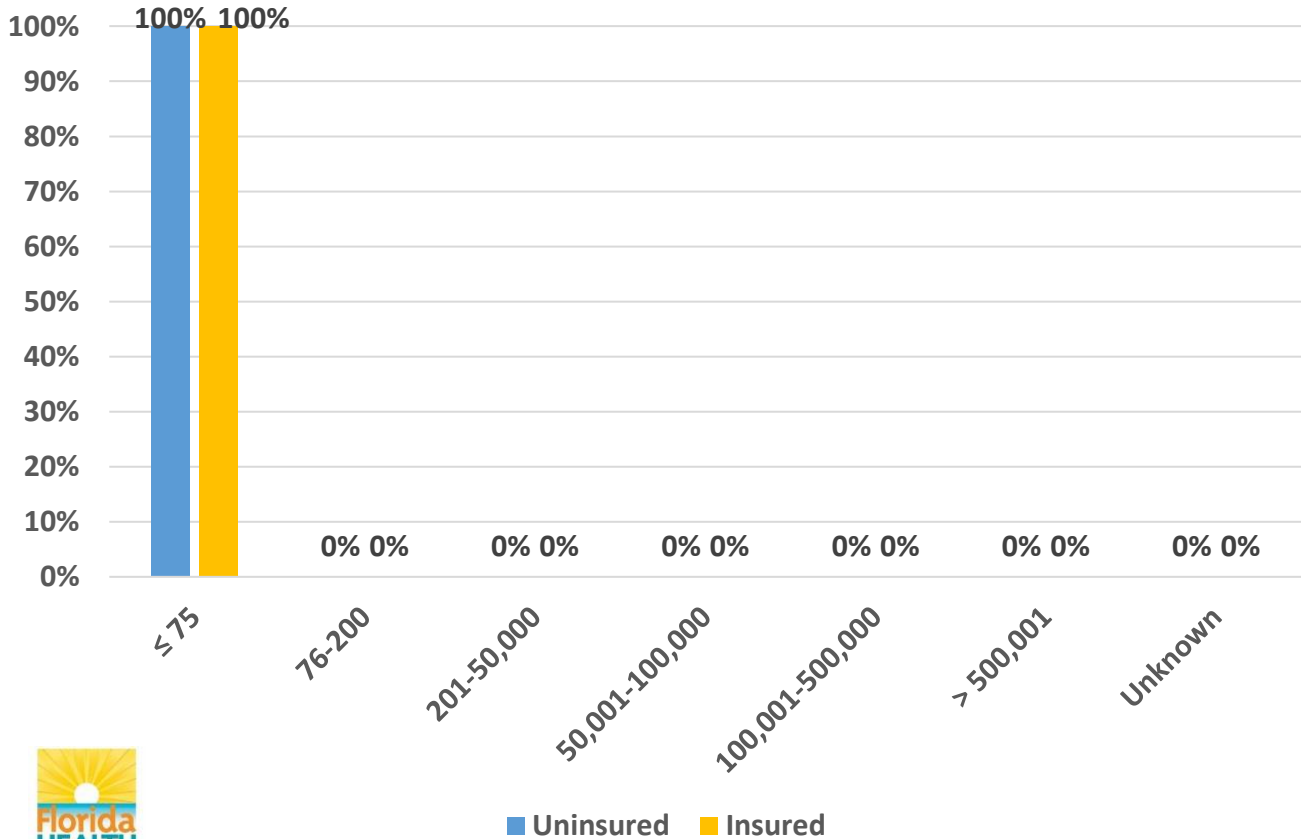

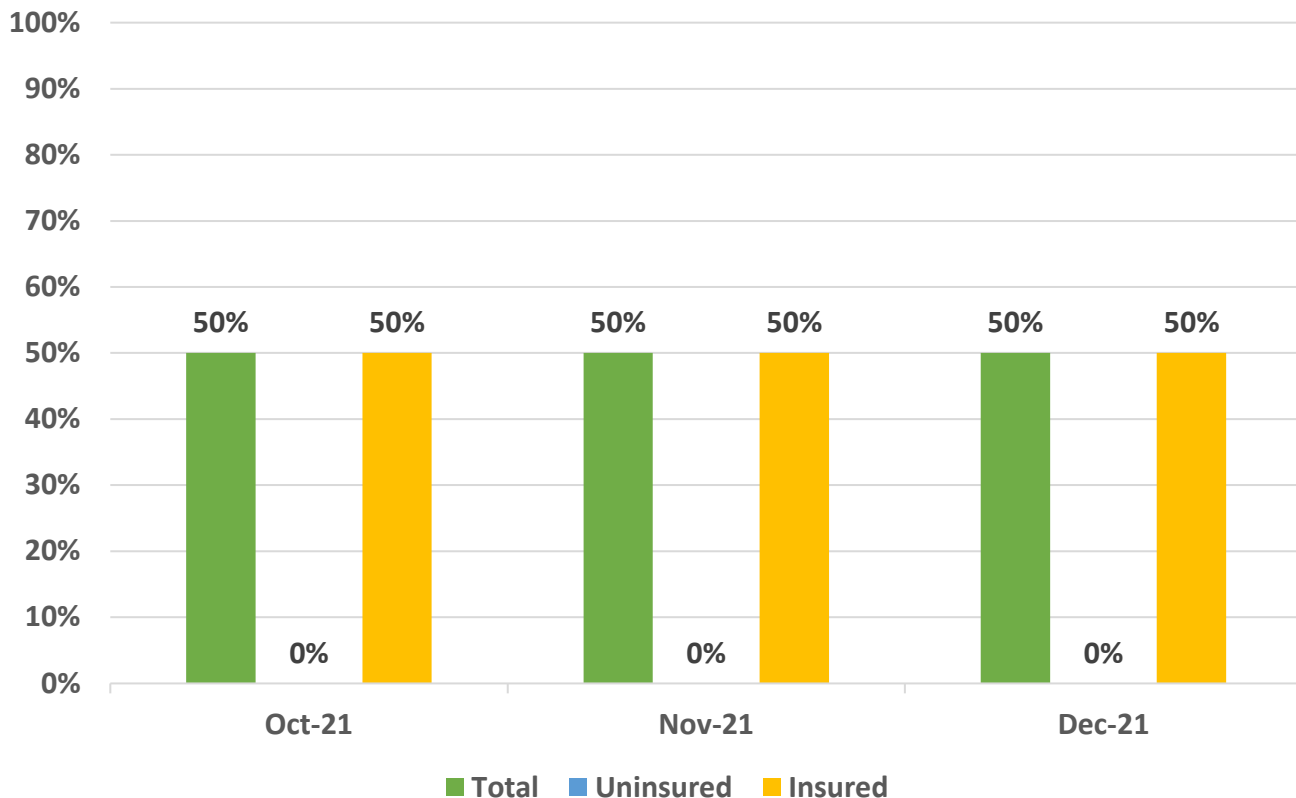

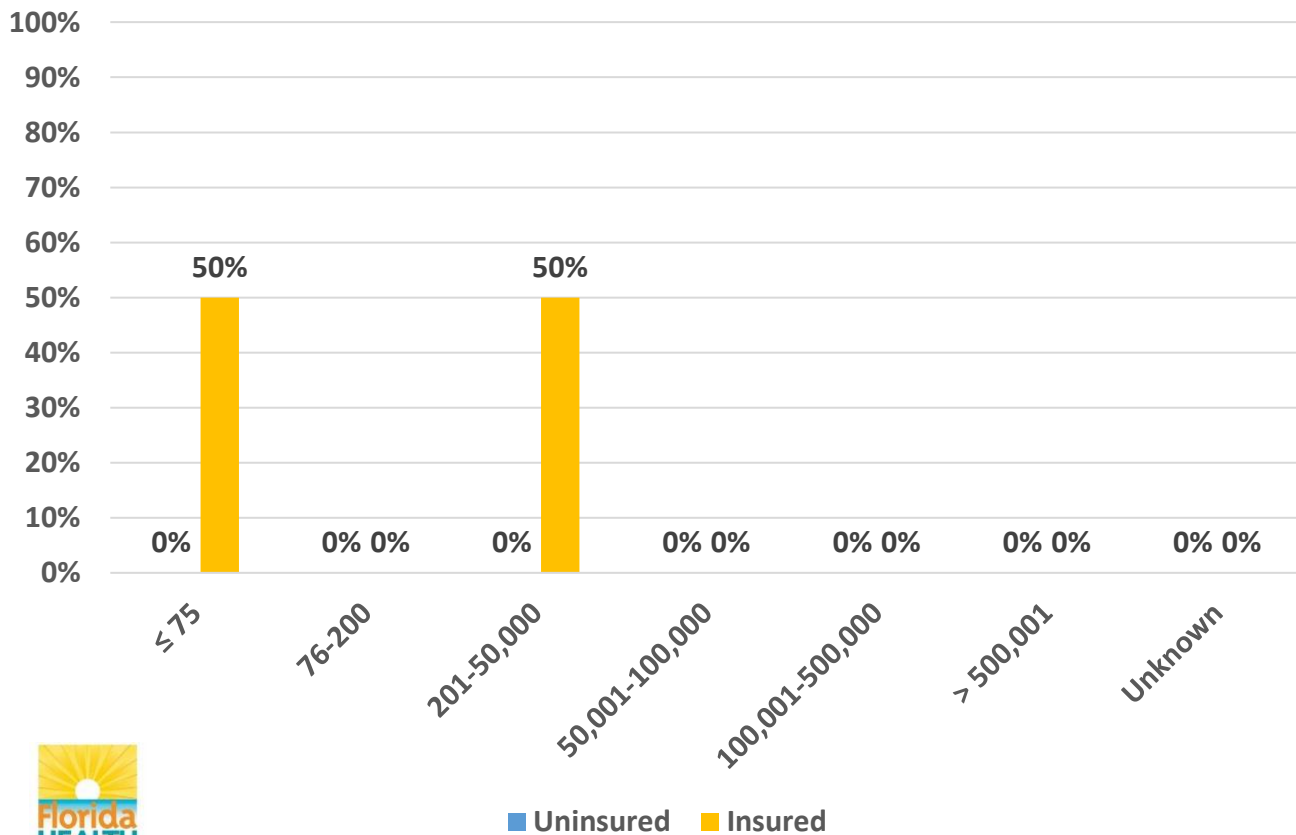
