	-Fill Urine between indicated Fill line.

	-DO NOT cover cap with parafilm
	-Make sure that the lid is on tightly -DO NOT puncture the foil cap
Minimum Volume	-Urine must be filled within fill lines.
William Volume	-Do not pour out or spill the media in collection kit. Use a new kit if media is
	spilled.
Storage Conditions	-Unisex or Multitest swabs stable 60 days at 2-30°C.
	-Urine - good for 30 days 2°C-30°C.
Collection Media	-For Urine specimen, use the <b>Aptima Urine Specimen Transport</b> Tube (YELLOW
	TUBE)
	-For Vaginal (preferred), throat, and rectal specimen, use the <b>Aptima Multitest Swab Transport Media</b> (ORANGE TUBE; PINK SWAB)
	-For Cervical, use the <b>Unisex Specimen Collection Kit</b> (WHITE TUBE;BLUE SWAB)

Specimen Labeling	-Specimen must be labeled with at least two unique patient identifiers, Ex: Name
	and DOB.
	-Electronic lab order preferred, HMS, WebLIMS, etc.

Packaging and Shipping Instructions and Handling	-Specimens must be shipped at 2-30°CIt is preferred to ship in coolers with ice packs and packaged with absorbent
and nanding	material in order to avoid possible leaks.
	-It is preferred that specimen are shipped in separate biohazard bags to avoid
	contamination in the event of a leak.
	-NOTE: If you do not ship the specimen in a cooler with ice packs, you must include
	a temperature indicator strip that will indicate if the specimen in your package went
	above 30°C during shipping. These can be purchased from <u>Fisher Scientific under</u> catalog number 22-111-005.




