#### Call to Order and Member Roll Call – Maggie Dilger, Florida Department of Health

Mr. Conley explained that the goal for the Annual Report is to discuss the accomplishments the council has made, and in future meetings the work plan will need some updates and possible council leads to accomplish.

There were additional questions from members related to the development of surveys. Staff explained that they have been researching surveys completed by other state RDACs and indicated that there would be further explained opportunities to collaborate with other groups withing the Department to survey the rare disease community, health care providers, and physicians. Any members with survey questions were directed to email council staff and those suggestions would be discussed at future meetings.
