4) CPT code 99483

Effective January 1, 2018, under CPT code 99483, clinicians can be reimbursed for providing care planning services to individuals with cognitive impairment, including Alzheimer's disease

Physicians, physician assistants, nurse practitioners, clinical nurse specialists, and certified nurse midwives can currently bill under this code.

Reimbursement rates can vary slightly based on the setting in which the service is provided and geographic location.
